## Blueberry Funded Scaling Program

Scaling refers to Blueberry Funded's ongoing simulated capital increase program, in which an earning account's simulated capital allocation is gradually increased based on their performance and adherence to risk management rules.

Simulated capital increments on the Blueberry Funded Account can occur every 3 months on eligible earning accounts.

To qualify for a capital increase, the earning account must generate at least 10% net profit over 3 consecutive months. Additionally, the earning account must process at least 4 payouts within the 3-month period.

## Scaling Plan Overview

- Upgraded Profit Split of up to 90%
- Balance Scale up of 25% every 3 months
- Ongoing Increases every 3 months if objectives are met
- Trading Objectives and Restrictions remain the same as your original Evaluation Outline on an increased simulated balance
- Maximum Simulated Capital Allocation per trader of \$2 million



**Additional Notes:**

1. All Access Fees published in this Trading Evaluation Outline and Fees Are exclusive of relevant taxes or other statutory or regulatory. You are responsible for paying any such amounts and the Company may withhold or recover such amounts from you in accordance with clause 14.
2. Active Trading Day refers to any single calendar day in which closed trades resulting in over 0.5% of initial balance in notional profit is accrued on a trading account.
3. Hedging Between Accounts Definition: Using 2 different trading accounts to open opposing trades on the same instruments with the same lot size at the same time
4. Rules for withdrawals: The first withdrawal can only be requested after 14 days of being an earning account funded trader.
5. No and Yes: No means that the feature is not allowed under any circumstances. Yes, means that the feature is allowed, subject to certain conditions.

7. During the funded stage, it is necessary for clients to maintain open positions for a minimum duration of 5 minutes in order for the positions to be considered valid.

8. Prohibited Gambling Trading Practices in the Earning Account and Evaluation Stages (Not applicable to stock challenges)

1. Overleveraging by trading over permitted fixed trade size limits in our FAQ

9. **Definition of Gambling Behaviour:** Definition of Gambling Behaviour: "Gambling" refers to actions that violate this policy as per the above list trading strategies in 8.

Traders are expected to maintain a disciplined and well-calculated approach, avoiding excessively risky behaviours. All updated binding information of Gambling behaviour is as per our FAQs at [help.blueberryfunded.com](https://help.blueberryfunded.com)

10. **Grid Trading Definition:** Grid trading in CFD (Contract for Difference) forex trading is a systematic trading strategy that involves placing a series of buy and sell orders at predetermined intervals (or "grid" levels) above and below a set price level.

11. **Assessment Structure:** The Assessment Program may comprise 1, 2, or 3 stages, or alternatively, an Instant Funding Program.

- For **Instant Funding Programs**, you will be granted access to a funded account immediately upon purchase. However, continued access and eligibility for profit withdrawals are subject to your adherence to the stated Trading Objectives and Risk Parameters. Breach of these terms may result in account termination or forfeiture of profits.
- For **multi-stage Evaluations**:

- If the Assessment Program comprises **1 stage**, you must meet the Assessment Criteria within the stated Assessment Period to pass the Evaluation.
- If the Assessment Program comprises **2 stages**, you must meet the requirements of Stage 1 to be eligible to proceed to Stage 2. You must then meet the Stage 2 requirements to complete the Evaluation.
- If the Assessment Program comprises **3 stages**, you must sequentially meet the requirements of Stage 1 and Stage 2 to be eligible to proceed to Stage 3. You must then meet the Stage 3 requirements to satisfy the Evaluation Criteria.

Each stage, including Instant Funding, is governed by specific rules and requirements outlined at the time of purchase.

12. **Definition of Balance Protection Cap:** In our Rapid Evaluations, the Balance Protector is activated once you achieve a 4% profit and the trailing drawdown locks in at breakeven. This feature includes a 1% safeguard to ensure that you do not withdraw your entire allowed drawdown and potentially breach the account.
13. **Definition of Inactive Trading Day:** An "Inactive Trading Day" refers to any calendar day during which no new trades are opened and no existing trades are closed in a trader's account. This includes days when a trader might log in to review the market or monitor open positions but does not execute any trading activity, such as opening, closing, or modifying trades. Inactive Trading Days are used to assess a trader's consistency and engagement with their trading account and may be subject to specific terms under activity requirements in our trading agreements.
14. **Definition of High Impact News Event:** A high impact news event, often highlighted in red on industry economic calendars, refers to scheduled economic data releases, central bank announcements, or political events that are expected to have a substantial effect on financial markets.
15. **Definition of High Impact News Trading:** The opening or closing of any positions within 2 minutes before or after a high impact news event.



16. **Definition of Daily Drawdown:** The Daily Equity Loss Threshold indicates the maximum amount of equity that can be lost within a single trading day without exceeding the account's allowable limit. This threshold is a predetermined percentage of the daily starting equity. For specific calculations of all drawdowns that relate to this outline, please refer to our FAQ at [help.blueberryfunded.com](https://help.blueberryfunded.com)

17. **Definition of Consistency Rule:** At the time of submitting a withdrawal request, no more than 30% of the profit balance in the account should be derived from closed trades or equity movement from a single trading day. In the event that the consistency rule has been breached, the withdrawal will be rejected and can be processed once no trading day accounts for 30% more of the overall profit on the account. Excessive breaches of this rule may result in the account being hard breached or reset to phase 1.
